EXHIBITOR INSURANCE (MANDATORY)

We also want to remind you that all Exhibitors <u>must have a minimum of \$5 million liability in exhibitor insurance</u>. Exhibitors can use their own insurance provider or our **Official Insurance Supplier** (link to https://www.exhibitorinsurance.com/pub/cnt/). Keep your proof of insurance at your booth during the show. Exhibitors MUST be able to show proof of coverage upon request. You do NOT need to submit a copy of your insurance to PDAC before the show. VOYAGE CONTROL

The MTCC uses an on-line loading dock booking system for reserving a loading dock date/time, powered by Voyage Control. This service helps you to reserve a time slot for moving your materials directly in and out of the MTCC loading docks. ALL alcoholic beverages must be purchased under the METRO TORONTO CONVENTION CENTRE (MTCC) liquor license. Any product not purchased under our liquor license will be legally confiscated. This includes unopened alcohol included in door prizes. All exhibitors must sign the MTCC Alcohol Waiver (link to https://cdn7.pdac.ca/web/files/MTCC_Alcohol_Waiver.pdf) by February 13, 2026 and submit directly to the MTCC as directed on the form.
